NOW THE CONDITION OF THE ABOVE WRITTEN OBLIATION IS THAT in the event of the above bounden _____ resigning or retiring from service without returning to duty after the expiry or termination of the period of training / study leave so extended or at any time within a period of after his return to duty, he shall forthwith refund to the Government or as may be directed by the Government to refund on demand the said sum at the rate of Rs. _____ (Rs. _____) on account of his having been granted extension of the period of deputation / study leave as aforesaid together with interest thereon from the date of demand at the rate of _____ percent per annum, and he shall also be liable to pay an amount equal to his _____ month's pay at the rate of pay last drawn and that the amount payable under this bond shall be recoverable as arrears of land revenue.

And upon the above bounden _____ making such refund, the above written obligation shall be void and of no effect; otherwise it shall be and remain in full force and virtue.

The Government of Gujarat have agreed to bear the stamp duty payable on this bond.
